My puppies are priced according to: quality(as per the AKC standard), size/weight, color, and sex.

Deposits are non-refundable unless there is a problem with the health of the puppy and seller decides the puppy can't be sold. Seller will then give you the choice between two other puppies of equal or more value. In case of a problem with accepting the puppy as scheduled, buyer's deposit might be transferrable to another puppy, with adequate notice, at sellers discretion.

Thank you for purchasing your puppy at Mystique Furbabies. I've done my best to ensure your puppy comes to you healthy and happy. I raise my puppies in a safe, healthy, loving environment which includes: current vaccinations/deworming, a premium nutritional diet, exercise, veterinary care and socialization. My puppies are sold with limited registration as companions only, unless I feel confident that you'll be giving the puppy a wonderful, loving home along with your plans to show/breed him/her. I require a phone interview before agreeing to any puppy sale. After a phone interview to discuss your future plans for the puppy, I will make the decision about unlimited/breeding registration. Every puppy is unique in appearance, personality, size, etc. I try to help you choose the puppy best suited for your family and lifestyle. Placing my puppies in a loving home and making the transition as smooth as possible for the puppy and you is my goal!

At the time of leaving for his new home, this puppy is guaranteed:

- 1) to be in good physical and emotional health.**
- 2) current on all puppy shots/dewormings**
- 3) will have a comprehensive health exam if time permits and I am able to schedule an appointment before leaving and has been issued a health certificate(unless you decide on a Saturday or Sunday to pick up your puppy & I am unable to schedule this appointment, before he leaves.)**
- 4) to be a purebred puppy.**

Buyer agrees to take puppy to a licensed vet within 72 hours of leaving sellers possession for an examination. Buyer agrees to send written results of vet exam to seller within 7 days.

Buyer agrees to provide puppy with routine preventative care, such as, but not limited to:

- 1) annual physical exam by vet.**
- 2) follow vet's guidelines for shots/dewormings/heartworm/flea/tick preventative.**
- 3) to provide adequate housing, food & water.**
- 4) not to allow dog to run loose.**
- 5) not take puppy to a public dog area(pet store, dog park, etc.) until all puppy shots have been completed.**
- 6) read the tips on my website in order to give the puppy the best beginning possible in his new home.**
- 7) most importantly, give him lots of love!!!!**

To keep this guarantee in force, the buyer agrees to these conditions.

This contract does not cover the dog's breeding potential or ability, or show potential, nor does it cover death or illness due to environmental circumstances or neglect.

There are no other warranties expressed or implied, except as herein stated. It is understood and agreed that the Buyer by signing this form has read and understands the provisions of this contract. Furthermore, this written agreement constitutes all conditions of the sale and no verbal statements either before or after the sale will be binding in any way.

Hernias are a fact of life during whelping. Most hernias aren't congenital and happen at birth when the mother pulls/chews through the cord. Large hernias, that might endanger a puppy's health will be repaired prior to leaving unless the puppy is to be spayed/neutered and my vet has agreed that it's all right to wait until that time to repair it. In order to prevent undue stress, coat loss, etc. on the puppy, the hernia will be repaired at the time the puppy is spayed/neutered.

This guarantee will be null and void if:

- 1) Buyer gets any vaccinations for the puppy within 7 days after receiving puppy.**
- 2) Buyer uses any heartworm/flea/tick preventative containing Ivermectin (Heartguard) on a puppy weighing less than 4 lbs. I recommend Interceptor.**
- 3) Buyer allows vet to give a full dose of any vaccine on a Brussels Griffon puppy weighing less than 4 lbs. Please tell your vet to use half doses until the puppy is over 4 lbs.**

- 4) Buyer does not take this puppy to a veterinarian, within 72 hours after receiving the puppy, for a check up and then send the vet's report to the seller within 10 days after the checkup.**

If within 2 years after receiving puppy the buyers veterinarian discovers a congenital defect that will interfere with the normal life function or health of the puppy, replacement will be made as soon as a puppy of equal quality is available, upon the return of the puppy and the registration papers at the buyers expense. Puppy's guarantee does not cover treatable conditions that may be triggered by the stress of travel, new environment, etc. If buyer decides to sell or otherwise dispose of dog, seller has first right of refusal, at current market value.

The age at which a puppy can leave is based on their size and personality. A sensitive puppy requires more assurance and socialization and may need to leave a week or two later than his littermates. Also, if there are very small children or large animals in the home a puppy may need to be a little larger and sturdier before leaving. I prefer no puppy leave before 10 weeks but will discuss this with you. It isn't true that you need to bond with your puppy by eight weeks, when in fact that is a more vulnerable age and a puppy can be traumatized more easily.

Mystique Furbabies does not ever sell to pet shops, brokers or puppy mill breeders. Nor will we sell our puppies to a breeder who will sell their offspring to pet shops or brokers. If a puppy is purchased for one of these Buyer will be liable for the maximum penalty allowed by law under this contract. Buyer understands that if they breed this dog, none of its offspring will ever be sold to a pet shop, puppy mill or wholesale broker. Should buyer do so, there will be a \$500.00 penalty assessed for each puppy sold to one of these parties. In this way, we are able to protect the Mystique Furbabies bloodlines.
